Our Story

The story of the Pine Tree Apple Tennis Classic (PTATC) is an amazing one. Ron and Mary Ann Peterson created the PTATC in 1986 when their 12 year-old daughter Julieann was diagnosed with leukemia. Their mission was to raise money to provide the medical professionals at Children’s Minnesota a means and a way to research, while still being able to perform the crucial efforts of treating children with cancer.

At that time, there were no meaningful tumor registries and protocols for how to treat many cancers with a high degree of success. The Peterson’s wanted to give back after receiving such great care for their daughter and contribute towards the fight to end pediatric cancer.

Thirty-five years later, the PTATC hosts more than 100 of the area’s top men’s and women’s tennis players each August during this annual, mixed-doubles tournament.

Finding a Cure

To date, the PTATC has raised over \$5.7 million for targeted research programs at Children’s Minnesota that explore how to treat cancer and ensure the best overall, long-term outcome for patients. These research efforts ensure that children around the globe can be offered state-of-the-art treatment, thus improving their chances for survival.
































Because of PTATC funded research, all kids diagnosed with cancer at Children’s Minnesota receive physical therapy as part of their treatment plan - helping kids continue to be kids during and after treatment.

35-Year Celebration Sponsorship (\$3,500)

In addition to complimentary entrance to the 4-day tournament, reserved seating at the tournament, recognition on our event website and social channels and recognition on general event signage, this sponsorship level includes special recognition during one tournament day.

Specifically, on your assigned day, you will be recognized as a "35-Year Celebration Sponsor" on special signage located at the Life Time main entrance where tournament players and spectators check in. Additional, special signage will be placed near the Food Tent. You will also be recognized on table top signage located throughout the outdoor, tournament space. Our tournament announcer will also recognize your sponsorship on your assigned day.

The 35-year celebration sponsorship will be limited to eight sponsors--two sponsors per tournament day. Tournament day assignments will be made on a first-come, first-served basis. For example, if your first choice day to be recognized is Saturday, August 8, but there are already two sponsors assigned to that day, you will be asked to choose another day.
